

To access higher withdrawal limits, fiat features, and many advanced tools, you'll need to complete Binance's identity verification (KYC). Completing KYC is a standard, legitimate step that protects your funds and ensures regulatory compliance. With the right preparation and approach you can finish verification smoothly — often within a few hours to a few business days.

### Why Verification Matters

KYC (Know Your Customer) helps Binance confirm account ownership and reduces the risk of fraud, money laundering, and unauthorized activity. Verified users typically enjoy higher withdrawal limits, fewer restrictions during normal use, access to fiat services where available, and eligibility for certain Binance promotions. Think of KYC as a one-time step that unlocks the platform's full functionality while protecting you and your assets.

**Documents You'll Need**

Requirements vary slightly by country, but the most common items are:

- **Government-issued photo ID:** passport, national ID card, or driver's licence (clear color photo).
- **Selfie or liveness check:** a real-time selfie or short video to prove the ID matches you.
- **Proof of address (if requested):** a recent utility bill, bank statement, or government letter dated within the last 3 months.
- **For businesses:** company registration, proof of beneficial ownership, tax ID, and director IDs.  
Make sure images are full-page, uncropped, and legible. Accepted formats are typically JPG, PNG, or PDF.

### Step-by-Step Verification Workflow

1. **Complete your profile exactly.** Enter your legal name, date of birth, and address exactly as shown on your ID. Small mismatches are the leading cause of rejections.
2. **Use the official Binance app or website.** Start KYC from the verified Binance portal to ensure you're in the correct flow. Mobile apps often handle liveness checks more reliably.
3. **Upload high-quality photos.** Natural lighting, plain background, and steady hands help. Avoid filters or edits. If possible, scan documents into PDF for clarity.
4. **Follow the liveness prompts exactly.** Complete any head movements, blinks, or on-screen actions precisely. If a check fails, retry in a well-lit environment or on a different device.
5. **Submit business documents together.** For corporate KYC, upload all required paperwork in a single submission to reduce back-and-forth.
6. **Monitor your verification status.** If Binance requests additional info, respond promptly to avoid re-entry into the queue.

### Common Issues & Quick Fixes



- 
- **Name mismatch:** Make the Binance profile match your ID exactly. If you legally changed your name, upload supporting documents (marriage certificate, deed poll).
- **Blurry or cropped images:** Re-scan or re-photograph using a different camera; convert to PDF if needed.
- **Liveness check failures:** Remove glasses/hats, ensure face is centered, and retry on a device with a good front camera.
- **Address problems:** Provide multiple proofs (utility bill + bank statement) showing consistent address information.

### Business Verification Tips

Corporate KYC often takes longer. Prepare company registration docs, shareholder lists, proof of beneficial owners, recent corporate bank statement, and IDs for listed officers. If documents are in another language, provide notarized translations if requested. Submit a concise cover letter or summary of ownership structure to help manual reviewers.

## Security & Post-Verification Best Practices

- **Enable Two-Factor Authentication (2FA)** immediately (Google Authenticator or hardware key).
- **Change your password** to a strong, unique phrase after verification.
- **Keep recovery info up to date** (backup email and phone).
- **Store uploaded documents securely** for potential re-verification.
- **Avoid sharing login or 2FA codes** with anyone or using third-party “account services.”

Include your case reference and a concise summary of the files you submitted. For business accounts, use Binance Business channels where available. Polite, clear follow-ups often speed up manual reviews.
