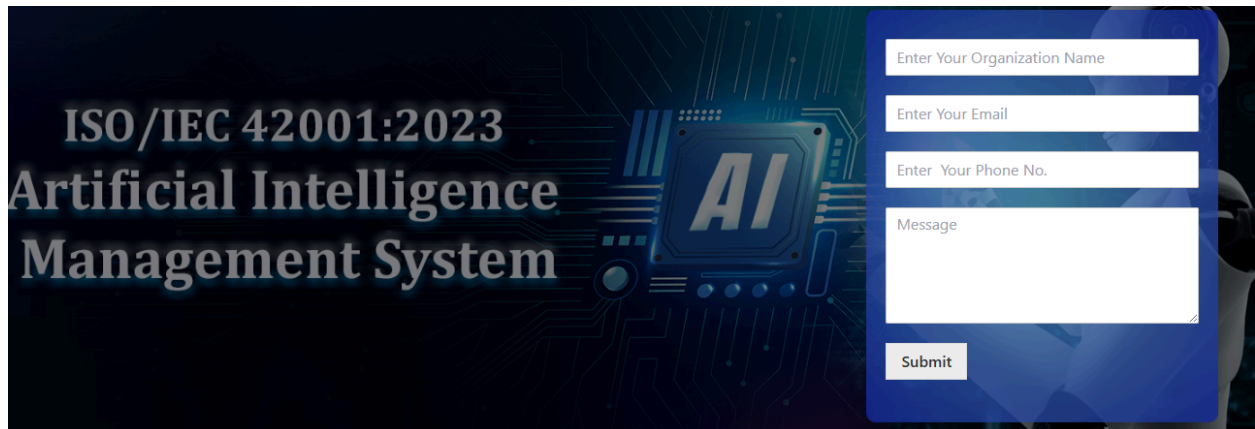


What is ISO/IEC 42001 Certification and its Requirements
